2022 public comment period on duties of precinct officials

The Democrat-controlled Board of Elections proposes to rush through changes to rules that govern the behavior of precinct officials. We oppose these changes for many reasons:

- Rules, laws and policies are already in place; these changes are not needed.
- Election workers already attend compulsory training and know the rules.
- It is too close to the election.
- The public does not have time to make a thorough review.
- Poll workers would be prohibited from any political activities between the opening of early voting and the end of Election Day.
- GOP would be required to provide an advance list of approved poll observers and no changes would be allowed.
